



## Crohnproof Privacy Statement

### Personal Data Processed

Crohnproof may process personal data about you because you use the services of Crohnproof, and/or because you provide it to Crohnproof yourself when filling out a contact form on the website. Crohnproof may process the following personal data:

- Your first and last name
- Your address details
- Your phone number
- Your email address
- Your IP address

### Why Crohnproof Needs Data

Crohnproof processes your personal data to be able to contact you by telephone or email if you request it and to send you informational emails if you have given permission for this. In addition, Crohnproof may use your personal data in the context of performing a contract of assignment with you, usually consisting of conducting (online) consultations and/or offering various lesson programs and related services.

### How Long Crohnproof Stores Data

Crohnproof does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. Your data will not be stored for more than a year if no agreement is concluded with you.

### Sharing with Others

Crohnproof provides your personal data to third parties only if this is necessary for the execution of an agreement with you, or to comply with a legal obligation.

### Mapping Website Visit

General visit data is kept on the Crohnproof website, including the IP address of your computer and the time of retrieval and data that your browser sends. This data is used for analyses of visit and click behavior on the website. Crohnproof uses this information to improve the functioning of the website. This data is anonymized as much as possible and is not provided to third parties.

### Google Analytics

Crohnproof uses Google Analytics to track how users use the website and how effective Crohnproof's Adwords ads are on Google search result pages. The information obtained, including the address of your computer (IP address), is transferred to and stored by Google on servers in the United States.
